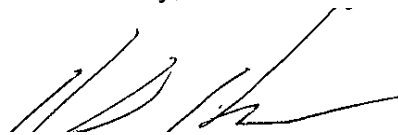
Moving the Department into the Future and to Develop Capacity to Deal with Change.
