Campgrounds are for Competition Shooters & Recreational shooters only.

Competition shooters have priority over recreational shooters. Competition shooters must provide an event or shooter number or ID.

RV CAMPGROUND CLAY TARGET CENTER: Shooters utilizing our trap, skeet, or sporting clay ranges may enjoy the 100 full hook-up RV campsites at the west end of the facility. RVs, fifth-wheels, and campers up to 55 feet in length are welcome. Spots are available on a first-come, first-served basis, and reservations are required. Laundry facilities are available as well.

Zone 3 in the Central Shooter's Campground and your site number. Please notify the office of emergency; after business hours, notify the AZGFD radio room.

Rifle & Pistol Range Facility details:

East Campground: located closest to the Rifle and Pistol Public range. This campground includes showers, laundry & dump station access. 95 sites.

- Utility spaces (1-53) - Electric, Water & Dumpstation included.
- Non-Utility Dry (54-95)- \$20 dump & fill fee per use.

Central Campground: Located at the Rifle & Pistol range near the Mounted Shooting arenas. 24 sites with full hookups (water, electric & sewer)

- RV space with Water, Electric & sewer hookup.
- Space 1-18 (30 amp) 19-24 (50 amp)

38 Covered **horse stalls** available for Mounted Shooters to reserve for the day or overnight (see Mounted Shooters' specific rules)

*Restrooms, showers, laundry facilities, and dump stations are only for those staying in the Shooters' East Campground or the Central Shooters' Campground

Extended stay shooters

Extended stay reservations (more than 14 days) must be requested a minimum of two weeks in advance, via email. Range Manager approval required. **Any extension requests after the initial stay also require Manager Approval.**

Please call the office after submitting an extended stay request if your anticipated arrival date is less than two weeks out.

Reservation requests may take up to 3 days to process.

Recreational shooters

Recreational shooters must purchase shooting passes upon arrival or provide documentation of range usage if booking online range time. Purchasing 3 range passes is required per stay/week.

Extended stays past 14 days for recreational shooters will not be approved during the busy season (October 1st – April 30th). Exceptions can be made at the Range Manager's discretion

Making reservations

***By submitting a reservation, I agree to all the Campground rules and understand that I may be asked to leave if I fail to comply with the campground rules.**

All reservations must be submitted through the Arizona Game and Fish Department website. Fill out all boxes; **incomplete forms will be declined.**

Website: [BASF Camping](#). No phone reservations will be accepted. The guest's name must match the credit card used for the reservation. If the names on the reservation and credit card do not match, your camping application will be declined.

You will be charged for the days you request to stay on your application. For changes to your reservation, contact the Store 24 hours before you arrive.

- If your competition runs past the check-out time of 1 PM, please purchase an extra day or vacate the camping spot before 1 PM.
- Please list additional occupants in your campground form. An Emergency contact number is required.
- Once you have submitted your campground reservation, you will receive a confirmation email regarding your stay. After-hours gate codes and directions to get to your site are provided by email prior to arrival.
- One night **NON-REFUNDABLE** deposit is due to secure your campspot. The name on the credit card must match the name on the reservation. Deposits are required to be paid 48 hours after receiving the

confirmation email.

- The reservation will not be considered finalized until the deposit is received.
- Failure to pay the deposit within the established time frame will result in the immediate forfeiture of the reservation.
- Deposits will not be refunded or rolled over to your next stay. **Gate codes will not be provided until the deposit is paid.** Do not share the gate code with anyone else.
- Check-in time is 3:00 PM, and Check-out time is 1:00 PM.
 - Later check-out or early check-in times must have prior approval from the facility office, and fees may apply.
- Fees must be paid in full upon arrival or the next business day if arriving outside of normal business hours.

General Campground Rules:

1. No early departure refunds are given.
2. We cannot guarantee availability for early arrivals.
3. Unused portions of your stay may not be used for future reservations.
4. Cancellations must be given within 7 days in advance of the arrival date.
 - a. **Furthermore, all cancellation requests must be submitted via email.**
 - b. Excessive cancellations and/or no shows may result in cancellations and/or rejection of future reservations.
5. Failure to arrive within 24 hours after your arrival date, your space/ stall will be released to the next camper. Please notify the Range Office if you are running late.
6. Vehicles, trailers, and campers left after check-out time, without prior facility office approval, may be towed at the owner's expense.
7. Maximum of six people per site, including daily guests.
 - a. Prospective campers must disclose the names of all adult occupants inhabiting the campsite during the reservation prior to reservation confirmation.
8. The primary occupant of the site must be the person whose name is on file for the reservation.
9. Children under 16 years old must be supervised by a responsible adult at all times.
10. Quiet hours are between 10:00 PM and 7:00 AM.
11. Camp Hosts are there to assist with basic maintenance issues, such as

- water leaks, broken infrastructure, and out-of-stock toiletries. Please notify a camp host of any issues during the camp host hours, 8:00 AM to 7:00 PM.
12. All range areas are closed after hours. Do not enter the range areas when the facility is closed.
 13. Parking along roadways is not permitted. Driving is only permitted along developed roadways, and drivers must follow the posted speed limits.
 14. No amplified sound devices are permitted outside of campers. Volume levels must be low enough not to disturb adjacent campers. All outdoor lights must be dimmed so as not to disrupt other campers.
 15. Only Liquefied Petroleum Gas (LPG) grills are permitted to be used in the campgrounds. Fires must not be under any overhanging branches and must be attended at all times. No other campfires or grills are permitted. No wood pellet stoves.
 16. ONLY properly grounded tools, equipment, and extension cords may be plugged into BASF outlets in the pedestals. The Ben Avery Shooting Facility is not responsible for damages to equipment while being plugged into pedestals.
 17. All modifications and/or alterations to the site require prior written approval from the Range Manager. This includes but is not limited to fencing and shade structures. ONLY 6" stakes are permitted for tents & shades.
 18. All trash must be placed in the provided trash receptacles.
 19. Ben Avery Shooting Facility is not responsible for any damage, accidents, or injury to guests or their property. BASF is not responsible for any lost or stolen valuables.
 20. No dumping of gray water discharge anywhere except into the dump stations.
 21. Feeding of Wildlife is illegal under A.R.S. 13-2927; violators will be prosecuted. Campers are required to immediately report any nuisance wildlife to the Range Master-in-Charge (RMIC) during business hours. For after business hours reporting, campers must contact the Arizona Game and Fish Radio Room.
 22. Harassing, hunting, or killing of any wildlife on BASF is illegal and strictly prohibited and will be reported to the appropriate authorities.
 23. For everyone's safety, alcohol is not permitted at any time at the Ben Avery Clay Target Center and Archery Range.
 - a. The only exception is in the Banquet Hall when a proper Special Event Liquor License has been obtained and displayed, or RV Residents and their guests inside the RV Campground after

concluding all shooting activities.

24. Maintenance on RVs and vehicles must be approved by the Range Manager before any work is conducted. Changing oil/vehicle fluids in the RV Campground for Shooters is strictly prohibited. Please notify the office if your RV requires service from a third-party vendor.
25. Mail and Package services are no longer available at The Ben Avery Shooting Facility Campground. Campers will need to make arrangements for their mail if staying for an extended period.
26. Please contact the RMIC # or the store first if you are having issues with your campsite. Only contact Camphost if you have already tried contacting the store and the RMIC number. Do not attempt to work on AZGFD electric, water, or sewage boxes.
27. RV sites must be kept neat and clean for the duration of the stay. Any items left outside of the RV must be neatly organized.
 - a. A \$30.00 per hour fee (minimum of one hour) will be assessed for each BASF employee required for any cleanup.

Clay Target Center Specific Rules:

1. No tent or dry camping. One camper (motorhome, travel trailer, etc.) plus two other vehicles are permitted per space. No more than three total vehicles/trailers may be kept per space.
2. After-hours entry to the CTC's RV Campground is through the CTC main entrance.
3. For extended stay, a minimum of \$25 in targets (or 3 archery range passes) for each week's stay is required. This fee is to be paid up front upon arrival.
4. All fees must be paid at the Pavilion office.
5. Laundry facilities and a dump station are for CTC RV Campground residents only.
 - a. Unattended laundry for extended periods of time will be removed from the washer or dryer.

PET POLICY

- All animals must be on leash not to exceed 6 feet or otherwise confined and under the owner's /custodian's control at all times. Electronic leashes are not acceptable.
- Pet waste must be **immediately** removed and disposed of in the proper receptacles by owners. Failure to follow Phoenix City Codes 8-14 & 27-12 will result in you forfeiting your stay and may result in your immediate removal

from the facility.

- a. A \$30.00 per hour fee (minimum of one hour) will be assessed for each BASF employee required for any animal cleanup.
- Excessive barking or aggressive behavior is not permitted. Pets must not be kenneled, tied up, or left unattended outside of the RV. Pets are not permitted in bathrooms, showers, or the laundry room.

Mounted Shooters' specific rules:

One night **NON-REFUNDABLE** deposit is due within 48 hours of your confirmation email.

- a. A failure to pay the deposit within the established time frame will result in the forfeiture of the reservation.
 - b. Deposits will not be refunded or rolled over to your next stay. Gate codes will not be provided until the deposit is paid. Do not share the gate code with anyone else.
1. You must be attending a Mounted Shooting event to book horse stalls. Covered barn stalls are available for horses. Note that this is not a boarding facility, and the owner is responsible for horse care and stall cleaning.
 2. Owners must make bedding arrangements, as BASF does not provide it.
 3. Stalls are rented by the day; if rented for more than one consecutive day, the night is included. Stall rental is from 6:30 AM - sundown.
 4. Overnight stall rentals are only permitted with an RV stay.
 5. Each horse owner is responsible for the daily cleaning of stalls and campsites.
 - a. At check out, the stalls and campsites must be free of manure, hay, straw, and all bedding.
 6. All animal waste must be placed in the dumpster. Failure to clean your stall will result in a \$30 per hour cleaning fee that will need to be paid before your next stay.
 - a. The area should be damage free when you arrive as well as when you check out. If there is damage upon arrival, please call the RMIC/store to report it. If there is no notification and we find damage, the last person using it is held responsible.
 7. Dogs must remain on a leash at all times. Failure to keep your dog on a leash will result in forfeiture of stay and may result in your immediate removal from the facility.
 8. All horses must be kept in designated stalls or tied to your trailer. No picket

lines or temporary fencing are allowed. You may not ride to other ranges or facilities.

9. One horse per stall only.
10. Failure to follow rules will result in forfeiture of future stays.
11. Mounted shooters can only dry camp in designated areas assigned by BASF staff & only when the Central campground RV spaces are full.
 - a. A camping pass must be picked up from the Store & Operations Center and placed in your horse trailer or RV, visible to Camphost and staff.
12. If all stalls are full, you may bring self-standing stalls with the permission of BASF staff. ONLY 6" Stakes are allowed to be driven into the ground.
 - a. **Dry campers** must pay their stay & stall rentals in full within 48 hours after email confirmation.
13. A map will be provided for the designated camping area.
 - a. Failure to arrive within 24 hours after check-in of your reservation, stalls will become available for others. Please call if you are running late.
14. Unloading horses and loading horses at the stalls only.
15. Water at the horse arena is not potable.
16. **No parking or camping permitted near stalls or the tower.**
